To Distribution:

As you were previously notified, the Commission approved a Proposed Budget for Fiscal Year (FY) 2017-18 on April 27, 2017. On May 25, 2017, the Commission approved the Final Budget for FY 2017-18, which included minor changes compared to the Proposed Budget. The Final Budget, accompanying this letter, is being distributed to local agencies pursuant to Government Code Section 56381. The Auditor-Controller, pursuant to Section 56381, will apportion the net cost to local agencies and request payment from each local agency sometime before July 1, 2017. The Auditor is also allowed to bill for the administrative costs incurred by that office in determining the apportionment and requesting payment.
