## REQUEST FOR REFUND FOR LAFCO 2016-08-1-ANNEXATION 40 TO COUNTY SERVICE 12. AREA 132 (TR 36910).

Ms. Craiq presented this item. She said that the applicant had withdrawn the proposal in the early stages of the annexation process and was requesting a refund. She stated that approximately seven hours of work had been completed by staff and she was recommending a partial refund in the amount of \$4,600.00.

Commissioner Montanez stated that staff may have underestimated the amount of time spent, which would include today's meeting.

Mr. Spiliotis reiterated that the proposal was withdrawn very early in the process.

REQUEST FOR WAIVER OF FISCAL IMPACT REPORT REQUIREMENT FOR LAFCO 2016-04-1-REORGANIZATION TO INCLUDE ANNEXATION 84 (THE SUMMIT) TO THE CITY OF LAKE ELSINORE, CONCURRENT ANNEXATION TO THE NORTHWEST MOSQUITO AND VECTOR CONTROL DISTRICT AND CONCURRENT DETACHMENT FROM THE RIVERSIDE COUNTY WASTE RESOURCES MANAGEMENT DISTRICT.

Ms. Romo presented this item. She said that the proponents were requesting the fiscal impact report requirements be waived since approximately 80 acres is developable land and it fell below the 100 acre requirement.

# AUTHORIZATION TO PROCURE FINANCIAL ANALYSIS SERVICES-MENIFEE PROPOSAL FOR DETACHMENT FROM VALLEY-WIDE RECREATION AND PARK DISTRICT.

Mr. Spiliotis presented this item. He stated that the City of Menifee had decided to pursue detachment from Valley-Wide Recreation and Park District. He said assessments currently being levied by VWRPD would be assumed by the City. He said that there was two separate meetings of the agencies, at the request of LAFCO, to come to an equitable division of those assessments. Mr. Spiliotis said the two agencies were not in agreement therefore, LAFCO would seek a consultant for an independent fiscal analysis, the cost to be borne by the City of Menifee. He stated that the staff was requesting the Commission to approve the process of acquiring quotes for the RFP that will be posted and authorize the Chair to execute the agreement.

Robert Lennox, Community Services Director, City of Menifee, 18223 Kross Rd., Riverside, CA 92508. Mr. Lennox said he was in support of staff's recommendation of selecting a fiscal consultant, however, he wanted the selection process of a firm to be unbiased. He also stated he did not want a delay with processing the application.

Dean Wetter, General Manager, Valley-Wide Recreation and Park District, 901 W. Esplanade Ave, San Jacinto, CA 92582. Mr. Wetter stated that the District had a neutral position on the selection of a fiscal consultant. He asked that the consultant selected be someone that had not previously worked with the City or its staff.

Mr. Spiliotis stated that he would send a list of consultants to each agency to review before sending the RFP to those firms.

Moved (Jeffries) seconded (Tomanelli) to approve the Authorization to Procure Financial Analysis Services-Menifee Proposal for Detachment from Valley-Wide Recreation and Park District with the caveat that Mr. Spiliotis would supply the City and the District with a list of consultants prior to mailing the RFP
