SECTION 3.0 SERVICE LEVEL COMPARISONS

This section provides an overview of service levels being provided by the agencies within the western Coachella Valley. It compares standards of service, current service levels and per capita cost for the services included in this review. Service levels are determined by several factors, including the General Plan, funding sources, community values, and City goals and objectives. The approach to service varies across the agencies; some have opted to contract with Riverside County for police and fire services while others have established city departments. The comparisons shown below should be considered within the context of a City's financial condition, its potential for growth, and community demographics.

3.1 Summary

Table 3.1 summarizes the services provided by each of the agencies and the per capita cost of providing the services.

3.2 Law Enforcement

Law enforcement services are provided through city police departments and by contract with the Riverside County Sheriff's Department. *Table 3.2* summarizes the staffing and adopted standards. *Table 3.3* summarizes the response times as reported by the agencies.

3.3 Fire Services

Fire services are provided through city fire departments and by contract with the Riverside County Fire Department, which contracts with the California Department of Forestry and Fire Protection. *Table 3.4* summarizes the number of calls and average response time.

Within the study area, the cities report the following Insurance Service Office (ISO) ratings:

- Cathedral City = 3
- Palm Desert = 3
- Palm Springs = 3

The ISO rating determines risk based on a number of factors within a specified service area. The ISO evaluates local fire protection capabilities in service areas and assigns a protection class rating from 1 to 10. Class 1 represents exemplary fire protection, and Class 10 indicates that the area's fire-suppression program does not meet ISO's minimum criteria. Independent insurance companies use the rating to determine fire insurance premiums, with a lower rating providing financial benefit to local property owners. The level of service, funding and resources committed to fire protection by a local government has a direct relationship to the ISO rating received.

3.4 Park and Recreation Services

Park and recreation services are provided by the cities and the Coachella Valley Recreation and Park District. The services and amenities provided by public agencies are augmented by private HOAs and resorts offering a wide range of recreational facilities, including private community parks, golf courses, and sports venues. *Table 3.5* summarizes the agencies standards and existing service levels.

3.5 Library Services

Library services within the study area are provided directly by two cities, by the other cities as part of the Riverside County Library System, and by the County System directly in unincorporated areas. Table 3.6 summarizes library standards and current levels of service.

3.6 Solid Waste Services

Each of the cities within the study area has a franchise agreement with a solid waste service provider. The levels of service are similar, providing for curb side pickup and recycling programs. Under AB 939 the cities are required to report on the waste diversion within their jurisdiction; the requirement was 50 percent by the Year 2000. *Table 3.7, Solid Waste Service Rates* summarizes the current monthly service charges and reported diversion rates for Year 2004:
