## APPENDIX A

### SOLID WASTE FACILITIES

Solid waste that is generated within the cities in this MSR is disposed of in the landfills that are listed below. This detail is in addition to the information within each city's section. The facility information below has been compiled utilizing data from the California Integrated Waste Management Board.

**Badlands Sanitary Landfill.** This landfill is located at 31125 Ironwood Avenue. The facility encompasses 1,093 acres and is permitted to accept 4,000 tons per day. The operator is the County of Riverside Waste Management Department, and the estimated closure date of this facility was January 1, 2018.

**El Sobrante Landfill.** This landfill is located at 10910 Dawson Canyon Road in the City of Corona. The facility encompasses 1,322 acres and is permitted to accept 3,650 tons per day. The operator is USA Waste Services of California, Inc., and the estimated closure date of this facility is January 1, 2030.

**Frank R. Bowerman Sanitary Landfill.** This landfill is located at 11002 Bee Canyon Access Road in the City of Irvine. The facility encompasses 725 acres and is permitted to accept 8,500 tons per day. The operator is the County of Orange Integrated Waste Management Department, and the estimated closure date of this facility is December 31, 2022.

**Lamb Canyon Sanitary Landfill.** This landfill is located at 16411 State Highway 79 in the City of Beaumont. The facility encompasses 353 acres and is permitted to accept 3,000 tons per day. The operator is County of Riverside Waste Management Department, and the estimated closure date of this facility is January 1, 2023.

**Mid-Valley Sanitary Landfill.** This landfill is located at 2390 N. Alder Avenue in the City of Rialto. The facility encompasses 498 acres and is permitted to accept 7,500 tons per day. The operator is the County of San Bernardino Solid Waste Management Division, and the estimated closure date of this facility is April 1, 2033.

**Olinda Alpha Sanitary Landfill.** This landfill is located at 1942 N. Valencia Avenue in the City of Brea. The facility encompasses 565 acres and is permitted to accept 8,000 tons per day. The operator is the County of Orange Integrated Waste Management Department, and the estimated closure date of this facility is December 31, 2013.

**Puente Hills Landfill.** This landfill is located at 13130 Crossroads Parkway South in the City of Industry. The facility encompasses 1,365 acres and is permitted to accept 13,200 tons per day. The operator is County of Los Angeles Sanitation District 2, and the estimated closure date of this facility is October 31, 2013.

**San Timoteo Sanitary Landfill.** This landfill is located at San Timoteo Canyon Road in the City of Redlands. The facility encompasses 366 acres and is permitted to accept 1,000 tons per day. The operator is the County of San Bernardino Solid Waste Management Division, and the estimated closure date of this facility is May 1, 2016.

**Simi Valley Landfill & Recycling Center.** This landfill is located at 2801 Madera Road in the City of Simi Valley. The facility encompasses 298 acres and is permitted to accept 3,000 tons per day. The operator is Waste Management of California, and the estimated closure date of this facility is June 27, 2022.

**Victorville Sanitary Landfill.** This landfill is located at 18600 Stoddard Wells Road in the City of Victorville. The facility encompasses 80 acres and is permitted to accept 1,600 tons per day. The operator is the County of San Bernardino Solid Waste Management Division, and the estimated closure date of this facility is July 1, 2007.
