




NOTICE OF PUBLIC HEARING  
OF THE RIVERSIDE LOCAL AGENCY  
FORMATION COMMISSION

NOTICE IS HEREBY GIVEN that a public hearing will be held before the **Riverside Local Agency Formation Commission on Thursday, January 28, 2021 at 9:30 a.m.** on the proposals listed below. Due to the COVID-19 pandemic, this meeting will be held via teleconference from the Board of Supervisors Meeting Room, County Administrative Center, 1<sup>st</sup> Floor, 4080 Lemon Street, Riverside, California. Consistent with Governor Newsom's Executive Order N-29-20 if members of the public would like to participate in the meeting, they may do so via teleconference. Details of electronic participation will be available when the agenda is posted, at least 72 hours in advance of the Commission meeting. Comments submitted by 8:00 a.m. the day of the Commission meeting will be part of the public record and distributed to the Commissioners for their consideration.

1. **LAFCO 2020-26-4-Sphere of Influence Review and Confirmation for Desert Healthcare District (Coterminous) and a finding of exemption pursuant to the California Environmental Quality Act:** Boundaries extend throughout the Coachella Valley and surrounding desert communities with a total service area of 1,760 square miles.
2. **LAFCO 2020-27-4-Sphere of Influence Review and Amendment to Palo Verde Healthcare District (Addition) and a finding of exemption pursuant to the California Environmental Quality Act:** Boundaries include the City of Blythe and surrounding desert communities in the Palo Verde Valley adjacent to the Colorado River with a total service area of 1,033 square miles.
3. **LAFCO 2020-28-3&5-Sphere of Influence Review and Amendment to San Geronio Memorial Healthcare District (Addition) and a finding of exemption pursuant to the California Environmental Quality Act:** Boundaries extend throughout the Banning pass and includes the Cities of Calimesa, Beaumont, Banning and the community of Cabazon. The total service area is 356 square miles.

The above does not necessarily reflect the order in which the items will be heard. Previously continued items may not appear on this notice.
