NOTICE IS HEREBY GIVEN that a Public Hearing will be held before the **Riverside Local Agency Formation Commission**, in the Board of Supervisors Meeting Room, County Administrative Center, 1<sup>st</sup> Floor, 4080 Lemon Street, Riverside, California, on **Thursday, May 23, 2019 at 9:30 a.m.** on the following proposals:

**1. LAFCO 2019-01-1,2,3,4&5-Countywide Water & Wastewater Municipal Service Review - Western County Region, Pass Mountain Region, & Coachella Valley/Eastern Region Water and Wastewater Agencies and a finding of exemption pursuant to the California Environmental Quality Act:**

Western County: Agencies include City of Corona, City of Hemet, City of Norco, City of Perris, City of Riverside, City of San Jacinto, Eastern MWD, Edgemont CSD, Elsinore Valley MWD, Home Gardens County WD, Home Gardens Sanitary District, Jurupa CSD, Lake Hemet MWD, Rancho California WD, Rubidoux CSD, Temescal Valley WD, West Valley WD, Western MWD, and San Bernardino Valley MWD.

Pass/Mountain: Agencies include City of Banning, City of Beaumont, Beaumont-Cherry Valley WD, Cabazon County WD, Fern Valley WD, High Valleys WD, Idyllwild County WD, Pine Cove County WD, Pinyon Pines County WD, San Gorgonio Pass Water Agency, and Yucaipa Valley WD.

Coachella Valley/Eastern County: Agencies include City of Blythe, City of Coachella, City of Indio, City of Palm Springs, Chiriaco Summit County Water District, Coachella Valley WD, Desert Water Agency, Imperial Irrigation District, Mission Springs WD, Palo Verde Irrigation District, Valley Sanitary District, County Service Area (CSA) 51 (Desert Center/Lake Tamarisk), CSA 62 (Ripley) and CSA 122 (Mesa Verde).


**2. LAFCO 2019-03-3-Reorganization to Include Concurrent Annexations to Eastern Municipal Water District and the Metropolitan Water District of Southern California (110th Fringe) and a finding of exemption pursuant to the California Environmental Quality Act:** Generally located south of Baxter Rd., west of Menifee Rd., north of Running Rabbit Rd., and east of Whitewood Rd. located in the City of Murrieta.
