## 4. PUBLIC HEARINGS:

## NEW:

a. LAFCO 2013-02-4&5-Sphere of Influence Review and Potential Amendment - Desert Recreation District and finding that the Sphere of Influence Review and Potential Amendment is exempt from the California Environmental Quality Act (CEQA).

Ms. Craig presented the proposal as outlined in the staff report. She stated that the previous sphere of influence review had discrepancies between the staff report and the approved map. She said that this staff

report addresses those discrepancies in the recommendation. She also spoke about the amendment to the District boundary.

Chair Williams opened the public hearing and there being no one wishing to speak the public hearing was closed.

Moved (Jeffries) seconded (Montanez) to approve LAFCO 2013-02-4&5-Sphere of Influence Amendment - Desert Recreation District and find that the Sphere of Influence Amendment is exempt from the California Environmental Quality Act (CEQA). 5/0 (Henderson, Stone absent)

#### MID-YEAR BUDGET STATUS REPORT FISCAL YEAR 2013-2014. 7.

Mr. Spiliotis presented this item. He said that cost saving measures in the past that have been adopted by the Commission have had a positive impact. He said that operating costs are at 46% of budget and that at projected year end will be about 5% under budget. Mr. Spiliotis said that projected fee revenue will be about 30% below budget and partially offset by carryover of about \$25,000 for next year. He said that the he will be working with the Administrative Review Committee on next year's budget.

Moved (Montanez) seconded (Wright) to receive and file the Mid-Year Budget Status Report Fiscal Year 2013-2014. 5/0 (Henderson, Stone absent)

#### 8. LAFCO MEETING DATE CHANGE FOR APRIL 2014.

Mr. Spiliotis stated that at the last meeting the Commission discussed changing the meeting date for April 2014. He said the CALAFCO workshop conflicted with the current April date. He gave the Commission two locations and asked that the meeting date be changed to April 17, 2014. Mr. Spiliotis also mentioned that this will most likely be Commissioner Henderson's last meeting on the Commission.

Moved (Wright) seconded (Tomanelli) to change the meeting date to April 17, 2014 at 9:30 a.m. and to hold the meeting at La Quinta City Hall in the Council Chambers. 5/0 (Henderson, Stone absent)

#### 9. LEGISLATIVE REPORT AND POSSIBLE POSITIONS.

Mr. Spiliotis presented this item. He said that SB 772 has been amended and he recommended that the Commission take a formal position to support this bill. He said that SB 56 did not advance and that provisions from this bill were moved to SB 69 and that bill failed to advance but it was still alive. He said SB 69 will be amended to remove provisions to do with annexation of inhabited and developed territories and these provisions are being moved to AB 1521. Mr. Spiliotis recommended the Commission take a formal position of support for SB 69 and AB 1521 or whichever bill the provisions are lined up in to help these cities as well as inhabited annexations. He also spoke about the Assembly Local Government Omnibus Bill.

Moved (Wright) seconded (Tomanelli) to support SB 69, SB 772 and AB 1521 or any new bills that ends up carrying the funding for incorporations or inhabited annexations. 5/0 (Henderson, Stone absent)

#### 11. MISCELLANEOUS REPORTS.

Mr. Spiliotis said that the March meeting may be cancelled and that the next meeting would then be April 17th.

Mr. Spiliotis said nothing has been submitted by the City. He said that the City adopted a resolution of intent to initiate proceedings but nothing further.
