
## NOTICE OF PROTEST HEARING BEFORE THE EXECUTIVE OFFICER OF THE RIVERSIDE LOCAL AGENCY FORMATION COMMISSION

NOTICE IS HEREBY GIVEN that a Protest Hearing will be held by the Executive Officer of the **Riverside Local Agency Formation Commission (LAFCO)** at 6216 Brockton Avenue, Suite 111-B, Riverside, CA 92506 on **Monday**, **November 26**, **2018 at 1:30 p.m.** to receive written protest on the following proposal:

1. District, Perris Valley Cemetery District and Wildomar Cemetery District (subsidiary) and Detachments from Perris Valley Cemetery District, Elsinore Valley Cemetery District and Wildomar Cemetery District (subsidiary) and Associated Sphere of Influence Amendments:

This reorganization covers several different areas in and around the Cities of Perris, Menifee, Lake Elsinore, Canyon Lake and Wildomar, which are generally described below:

- Generally located south of Van Buren Blvd., west of Lake Perris Recreational Area, north of Markham St. and east of Barton St.
- Generally located south of Christmas Tree Ln., west of Gilmer Rd., north of Telford Av., and east of Walsh Rd.
- Generally located south of Ethanac Rd., west of the I-215, north of Wildomar Truck Trail, and east of Arroyo Rd.



Commission proceedings were initiated by resolution of application by Riverside County Board of Supervisors. The reorganization is proposed to realign each cemetery district's boundaries with the boundaries and spheres of influence of the underlying cities. The reorganization was approved subject to the terms and conditions outlined in LAFCO Resolution No. 15-18 which is available upon request through the LAFCO office.

Any registered voter or owner of land within the affected territory may file a written protest against the proposal with the Executive Officer of the Commission at any time between the date of this notice and the conclusion of the protest hearing on this proposal.

Written protest must be submitted on the official protest form on the reverse side of this sheet. Protests must be delivered to the following address prior to the conclusion of the hearing:
