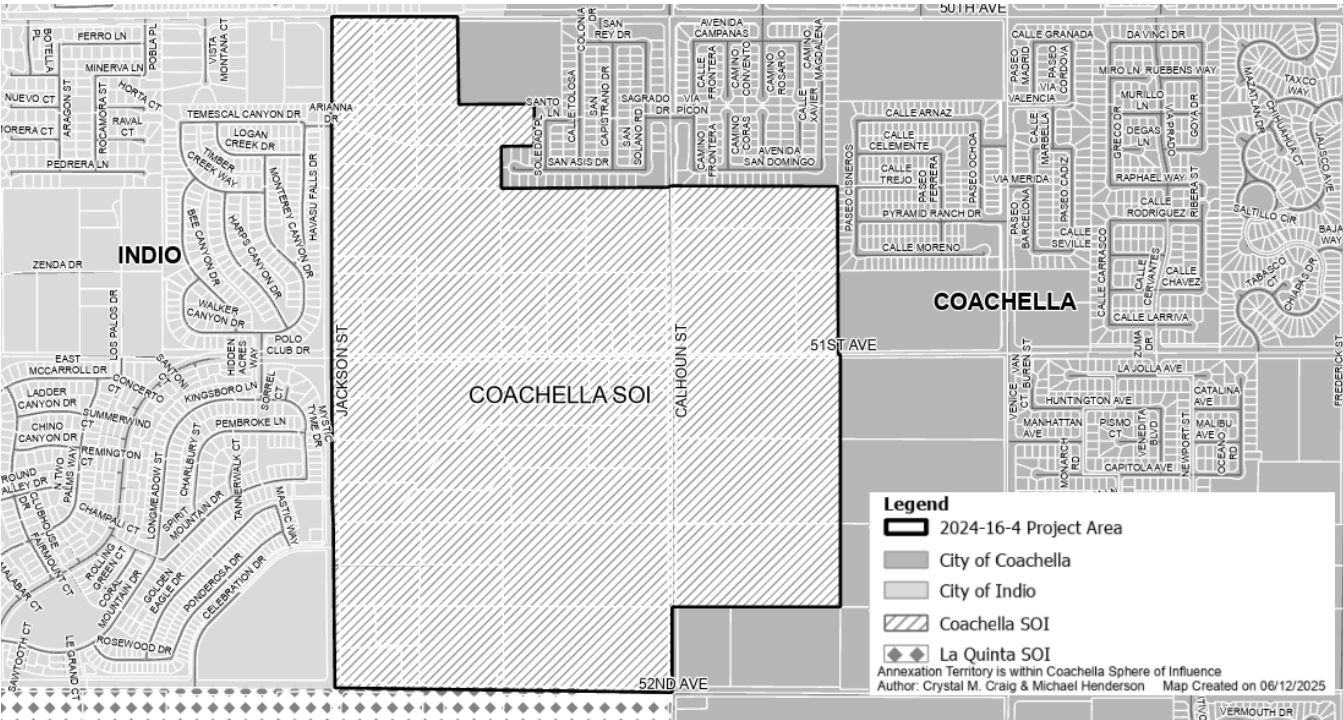


NOTICE OF PROTEST HEARING  
BEFORE THE EXECUTIVE OFFICER OF THE  
RIVERSIDE LOCAL AGENCY FORMATION COMMISSION

NOTICE IS HEREBY GIVEN that a Protest Hearing will be held by the Executive Officer of the **Riverside Local Agency Formation Commission (LAFCO)** at 6216 Brockton Avenue, Suite 111-B, Riverside, CA 92506 on **Wednesday, September 24, 2025, at 10:00 a.m.** to receive written protest on the following proposal:

- 1. **LAFCO 2024-16-4-Reorganization to Include Annexation to the City of Coachella, the Coachella Fire Protection District (subsidiary), the Coachella Sanitary District (subsidiary), and Detachments from the Coachella Valley Water District, County Service Area 125 (Thermal) and the Riverside County Waste Resources Management District (P7 & Mesquite):** Generally located south of 50<sup>th</sup> Avenue, east of Jackson Street, west of Van Buren Street, and north of 52<sup>nd</sup> Street, within the sphere of influence of the City of Coachella.



Commission proceedings were initiated by resolution of application by the City of Coachella. The purpose of the reorganization is for the provision of municipal services by the City of Coachella. The annexation was approved subject to the terms and conditions outlined in LAFCO Resolution No. 28-25 which is available upon request through the LAFCO office.

Any **registered voter residing within the territory or owner of land within the territory** may file a written protest against the proposal with the Executive Officer of the Commission at any time between the date of this notice and the conclusion of the protest hearing on this proposal.
